Design Guidelines for Artificial Turf

In Front yard and/or Exposed Yards

Any proposal to install Artificial/Synthetic Turf ("Artificial Turf") or to convert existing natural turf areas to artificial turf **must be submitted for approval**. The purpose of the review will ensure on-going compliance with the originally approved plans and to ensure such turf areas meet the minimum size, spacing, function, and connectivity to outdoor living areas, along with the need to modify the header from steel edging to a masonry/concrete border that is complimentary and compatible with the existing materials. These guidelines are applicable to residential, sub-associations and commercial properties and all require application for approval.

Application for Artificial Turf must meet the same front and backyard requirements for use of natural turf as identified in the DC Ranch Guidelines for each respective neighborhood.

The Modification Committee will review applications for the installation of Artificial Turf in the front yard, or any exposed area located outside enclosure walls. The following guidelines, specifications, and requirements are the minimum standards that apply to the use of Artificial Turf in front and/or exposed yards, and the Modification Committee and the Covenant Commission reserve the right to apply additional criteria, and stipulations as deemed appropriate to address the variety of possible conditions.

Size and Layout of Artificial Turf:

- 1) The minimum total square footage and dimensions of Artificial Turf for all exposed yard locations on a single lot shall be as reflected in the Neighborhood Requirements Summary chart below. Depending on the location of your property, Artificial Turf area may not exceed natural turf guidelines of the landscapable area.
- 2) Artificial turf areas shall be sized to resemble traditional natural turf areas; therefore, very small patches of artificial turf will not be approved.
- 3) No Putting Greens will be allowed in the front or exposed yard location.
- 4) Artificial Turf and natural turf are not allowed in the same exposed yard on a single lot.
- 5) The Artificial Turf shall be installed over an even plane. No mounding, berming, or contouring of the grade.
- 6) Artificial Turf must be surrounded by a permanent concrete, or masonry header, or curb, that is a minimum of 4" wide. Brick, Travertine, Concrete Pavers, or Extruded Colored Concrete are acceptable. Metal or plastic edging will not be allowed.
- 7) Artificial Turf must be placed a minimum of 36" away from the exterior wall of any building, or property line. This will allow the placement of natural shrubs and foundation planting against the base of the wall and/or structure.
- 8) Artificial Turf shall not be placed immediately adjacent to natural lawn, whether on the same lot, or an adjacent property. When natural lawn is on the adjacent property, both the Artificial Turf and the natural turf shall have a minimum of 36" wide planting separation from the property line.

Appearance and Material Specifications:

- 1) The Artificial Turf product or material must have the appearance of "natural rye grass" or "natural hybrid Bermuda grass, as determined at the sole discretion of the Modification Committee and the Covenant Commission, including but not limited to color, color variation, reflectivity, texture, coarseness, size of artificial grass blades, and top-dressing material.
- 2) Artificial Turf must include multi-shades of green grass blades, with a significant amount of tan thatch to provide the artificial turf a more, natural appearance.
- 3) Artificial Turf must have a minimum "face weight" of sixty-five (65) ounces as defined by industry standards, or a maximum face weight of eighty-five (85) ounces.
- 4) The "pile height", which is the height of the artificial grass blades, shall be a minimum of 1 ½" and a maximum of 2" in height. Pile height is measured from the top of the backing material to the tip of the common grass blade fiber strand.
- 5) The yarn fibers should be made of polyethylene (PE), polypropylene (PP) and/or nylon materials.
- 6) Surfaces must appear seamless, and edges must appear natural and well-groomed.
- 7) If more than one panel of Artificial Turf is proposed on a single lot, the "grain" or the "directionality of the fibers" shall be placed in the same orientation so that the different Artificial Turf panels appear the same when viewed from any point.
- 8) Infill material is required for all artificial turf to keep the grass fibers standing upright and vertical. The color of any granular infill material shall be such that it provides the appearance of natural turf. Infill must be a minimum of 3 pounds per square foot based on upon standards industry guidelines. Acceptable infill materials will include, but not limited to: recycled rubber crumb, acrylic-coated silica sand, thermo-plastic, elastomer-coated silica sand and semi-round silica sand. (Note: Infill refers to products placed between the blades or fibers of Artificial Turf blades. Infill is used to keep blades standing upright so as the Artificial Turf looks as natural as possible and keeps the Artificial Turf from appearing matted or flat.)
- 9) To guarantee a quality turf product, artificial turf must have a minimum of 8-year product warranty and two-year installation/workmanship warranty. Ensure the product choice uses only high- grade resins, as cheap-grade resins can fade, melt (due to poor UV stabilizers in the resin) or wear out prematurely.

Installation of Artificial/Synthetic Turf:

- 1) Artificial turf must be installed by a professional, qualified, or experienced contractor including, but not limited to Synthetic Turf Council certified turf installer. In addition, landscape contractors who have not been specifically trained in the installation of Artificial Turf are not allowed to install Artificial Turf.
- 2) Artificial turf must include a properly prepared appropriate compactable aggregate base of a minimum of two (2") inches with subsequent or additional base materials.
- 3) Acceptable backing materials included perforated, vertically draining polyurethane-coated materials to provide optimum tuft bind and maximum permeability. Felt or latex backing is not acceptable.
- 4) Total surface installation must be water-permeable with minimum twenty-five (25) inch permeability rating.
- 5) All job materials used for surfaces must pass applicable fire retardancy ratings.
- 6) Tree wells within the artificial turf shall be a minimum of 24" depending on the existing tree requirements. Drip emitter irrigation on trees within the artificial turf is required, additional deep root watering may need to occur due to the excessive surface heat the artificial turf could create.

Application

- 1) Applications for the use of Artificial Turf must be submitted for review to the DC Ranch Modification Committee. If the Artificial Turf is located at a new home under construction, the request must be submitted to the Covenant Commission per their standard submittal requirements. Construction or installation cannot commence until such approval is granted in writing by either the DC Ranch Modification Committee or the Covenant Commission. Failure to comply may result in the requirement to remove the unapproved Artificial Turf, the potential of imposing of fines, or any other remedies available to the Modification Committee/Covenant Commission, per the governing documents.
- 2) A submittal checklist will be provided with the request form. Ensure all submittal requirements have been addressed.

High-quality Artificial Turf shall be used in in accordance with the Community Design Guidelines and shall be maintained in good repair. Installation of Artificial Turf requires prior approval through the modification process as outlined below. Modification forms may be downloaded online at DCRanch.com and submitted to The Ranch Offices for review.

This maintenance requirement is for all artificial/synthetic turf ("Artificial Turf") installed with strict guidelines for type, quality, color, application and maintenance per the Community Design Guidelines and the requirements for both Artificial and Natural Turf.

Artificial Turf requires maintenance by Owners to keep it in an acceptable, aesthetically pleasing condition. Said maintenance is different than for natural turf, and includes but is not necessarily limited to sweeping, vacuuming, blowing, rinsing, rolling, infillⁱ replenishment, cleaning, disinfecting, pet waste removal and monitoring for general repairs.

All Artificial Turf surfaces must be always kept in a clean and attractive condition according to DC Ranch Community Standards staff determination. The following are examples of items not up to DC Ranch standards that shall be properly addressed: Artificial Turf frayed at the edges, loops that are pulled up, mat down, fading turf and general unsightliness and worn turf.

Any repairs to the Artificial Turf that are necessary must be uniform in installation and of the same material as the originally approved product. Repair work must match and blend seamlessly with existing artificial turf; if this cannot be accomplished, all artificial turf must be replaced.

If the Artificial Turf is determined by Owner or Standards Staff to be dilapidated, faded, or reached its useful life and therefore requires replacement, the Owner may replace the exact footprint of the same approved turf area without modification approval only if the Artificial Turf meets all the current DC Ranch guidelines on Artificial Turf in the private yard. If the Owner chooses not to reinstall Artificial Turf, a DC Ranch approved front yard landscape plan may be reinstalled without additional approvals provided it is compliant with current standards; notification to the Director of Modifications is required. If the Owner desires any changes from the original DC Ranch approved landscaping, then the Owner must follow the modification review process and submit the proper supporting documents for review.

Required Artificial Turf maintenance by Owner includes but is not limited to:

- Use of infill is required to keep blades standing upright so the Artificial Turf looks as natural as possible and keeps the turf from appearing matted or flat.
- Routine clearing of debris, rinsing and regular cross raking/brushing with a synthetic bristle rake
 or brush is required to help achieve a long, useful lifespan of the Artificial Turf. Cross
 raking/brushing against the grain will help to avoid the Artificial Turf from becoming matted.
- Regular cleaning of the turf to remove stains and odors and mitigate growth of fungus or mold.

The Association may reject or require the removal of an Owner's Artificial Turf if the Artificial Turf turf creates a health or safety issue that the Owner does not correct within the timeframe established by the Association.

The Association reserves the right to modify these requirements from time to time.

¹ Infill refers to products placed between the blades or fibers of Artificial Turf blades. Infill is used to keep blades standing upright so the Artificial Turf looks as natural as possible and keeps the turf from appearing matted or flat.
