Executive Director's Report

- Welcome Director of Community Services Scott Levy. Scott has experience in security program development, policies and procedures, access control, operations, budgeting, capital planning, and client/customer service. He grew up in the security business, as his family ran their own security company in Chicago for many years. He most recently served as Senior Manager of Global Security and Visitor Support at Mayo. Scott will work on CPGA services, support administrative office staff, play a lead role in the reserve study, and initiate and lead other resident-focused initiatives.
- *Open Recruitments.* DC Ranch Association is currently recruiting for Maintenance Manager and Deputy Executive Director.
- *NVM Elections.* Congratulations and thank you to newly elected NVMs. NVM onboarding is scheduled for Jan. 22, 2025. A special election for a Haciendas NVM will be held this month.

Executive Director's Report

- *Communications*. The Communications Team supported various Ranch Association communications and initiatives in December, including:

Old Business: Policy 102

Consider Approval of Amendments to Policy 102: Development and Management of Policies

- Posted for resident review
- Clarifies that the Board must authorize the posting of policy under consideration for resident review
- Review period changed from thirty to twenty days
- Review of policies is "as needed" in lieu of annually
- Numbering mechanism changed to be consistent with practice
- Language improved for clarity and consistency and to reduce redundancy with governing documents



Old Business: Policy 107

Consider Approval of Amendments to Policy 107: Neighborhood Committees

- Posted for resident review and comment
- Verbiage made consistent with governing documents
 - Purpose of Neighborhood Committee
 - Voting requirements
- Process clarified and streamlined
- Neighborhood Advisory Committee Request for Consideration Form will be used to facilitate the process



New Business: Parking Sticker Program

Background:

- Introduced in December 2019 by Board in response to resident concerns about parking issues in Park and Manor.
- Aim: To improve parking compliance and address non-compliance effectively.

Enforcement Process (2019 - 2024):

- 1. Courtesy Written Notice: Card/ticket placed on the windshield.
- 2. Final Reminder: Second card/ticket issued.
- **3. Sticker Notice:**
- Sticker applied to the driver-side window.
- Fine of \$50 per occurrence, escalating based on Board discretion.
- **4. Repeat Violations:** Each new violation incurred a sticker and additional fines.



Parking Sticker Program, continued

Policy Adjustments:

2021: Fine increased to \$300 per occurrence.

2024: Stickers applied only for repeat violations within 12 months. Compliance resets after 12 months with no violations.



Parking Sticker Program, continued

Impact:

- Deterrence: Visible enforcement reduced repeat violations in key areas.
- Resident Feedback:
 - Support: Improved parking order.
 - Concerns: High fines and visible stickers.
- Efficiency: Phased notices ensured clear communication before fines.

Challenges:

- Fines perceived as strict by some residents.
- Administrative efforts to track compliance and resets.



Parking Sticker Program, continued

Recommendation - Staff and the CPGA Committee to take the following steps and bring recommendations to the Board as appropriate:

- 1. Review and update Parking Standard DCR-12, including mirroring escalation scheme of Speeding Standard DCR-24 which includes 90-day payment of fines or vehicle transponder deactivation
- 2. Improve use of technology (software) for improving tracking and notifications
- 3. Explore additional and/or alternative means of enforcement for repeat/pattern infractions (in lieu of stickers)

In addition, staff will enhance communication about the standard to the community and will review and explore options with Community Standards and the CPGA Committee to identify improvements and ensure alignment with community needs.



New Business: CPGA Committee Membership

- CPGA Committee needs to recruit new members
- By charter, CPGA Committee shall have at least 5 and no more than 10 non-Board residents
- Former CPGA Committee member Karen Gallivan no longer sits on committee after election to DC Ranch Association Board
- Current active Committee members include Board Liaison/Chair Marla Walberg and 4 community members
- *Recommendation: Approve staff to conduct a call for CPGA Committee candidates*
